2. How We Use Your Information

We use your information to:

- provide access to PIC services and membership areas;
- process payments and renewals;
- manage subscriptions;
- communicate with members;
- improve our services and platform;
- provide customer support;
- send educational content, updates, and promotional communications;
- maintain security and prevent fraud;
- comply with legal and regulatory obligations.

3. Marketing Communications

PIC may send:

- newsletters;
- market updates;
- promotional emails;
- webinar invitations;
- membership updates;
- educational content.

You may unsubscribe from marketing emails at any time using the unsubscribe link provided in communications.

Operational and account-related emails may still be sent where necessary.

4. Automatic Renewal & Payment Processing

Membership payments and renewals are processed through secure third-party payment providers.

By subscribing, you authorise recurring payments in accordance with your membership plan.

PIC does not store full card payment details directly on its servers.



5. Sharing of Information

PIC does not sell your personal information.

We may share information with:

6. Data Retention

We retain personal information only for as long as reasonably necessary:

- maintain business records.

PIC reserves the right to retain certain records where required for legal, regulatory, fraud prevention, or operational purposes.
